2008 STALLION AGREEMENT

I \_\_\_\_\_ hereby referred to as donor, agree to **donate** to the BEEHIVE **FUTURITY** and 2008 Stallion Service Auction one breed to \_\_\_\_\_ (STALLION), hereafter referred to as stallion.

1. In return all foals by above **Stallion** will be eligible for the 2011 BEEHIVE FUTURITY, if said stallion's breed is sold, if not sold at auction the breed will be available for sale until **April 1, 2008**.
2. Also, in return, the UQHA agrees to give the donor a \$400.00 credit toward the nomination of foal (s) into the 2011 Beehive Futurity.
3. It is understood that said stallion's breed must sell for \$400 minimum or one half of the stallion's catalogued fee, whichever is greater, in order for any of his 2008 foal crop to be eligible for the 2011 BEEHIVE FUTURITY.
4. It is understood that 70 % of the 2008 Beehive Stallion Service Auction net income will be put into the 2011 Beehive Futurity. Once the breed sells, however all of the stallions 2008 foal crop will be eligible for the 2011 Beehive Futurity.
5. UQHA officers, directors, employees and stallion owners will not be held responsible for accidents to mares or foals while they are at the court of said stallion.
6. The mare owners will agree to abide by the terms of the stallion's breeding contract and to pay regular mare care and any veterinary costs prior to leaving the court of said stallion. Also, mare owners will agree that if the breed purchased is to be used on a mare other than a registered American Quarter Horse, the mare owner will seek and obtain prior approval from the stallion owner. Understand that this will make the foal ineligible to race in the 2011 BEEHIVE FUTURITY unless the resulting foal is legally registered as an American Quarter Horse with the AQHA.

PLEASE LIST YOUR STALLION'S FEE FOR THE 2008 BREEDING SEASON. Due to the terms of this sale no private treaties will be accepted.
